LeSauk Township Annual Road Inspection Meeting May 12, 2021

The Annual Road Inspection Meeting was called to order by Chairman Dan Heim at 4:00 p.m. in the Town Hall.

# PRESENT: Supervisors Dan Heim, Jeff Westerlund and Shawn Omann and Clerk Marlyce Plante.

The Town Board traveled all township roads. The majority of the roads within the township are in good driving condition. 30<sup>th</sup> Avenue is in need of the most repair. Doug Welk of ASTECH Inc., has stated in the past that the township should not put a lot of money into 30<sup>th</sup> Avenue, just maintain as much as possible.

22<sup>nd</sup> St. No. – Another street that Doug Welk of ASTECH Inc., has stated in the past the township should not put a lot of money into it, just maintain as much as possible.

35<sup>th</sup> St. No. – The portion located along the Lloyd Traut property and belongs to the township, is in need of some work. Another street to maintain until a paving project could be worked out with the city of Sartell since they own the portion of 35<sup>th</sup> Street that runs along the Blackberry Ridge Addition & Golf Course.

17<sup>th</sup> St. No. – Udermann area - This area was graded, but is still slightly washboard. The road will again be graded in the fall unless needed before then.

322<sup>nd</sup> St. – This street is in poor condition but has been patched by St. Cloud since the majority of the south side is in the city. There is a lot of traffic on this road, both trucks, cars and farm equipment. Patch and fix as needed.

Supv Heim and Supv Westerlund spent several hours patching potholes on roads throughout the township. They used 1000 lbs. of cold patch and could have used more. The majority of potholes were taken care of on township roads.

The following are areas that need to be addressed and considered:

#### Crack Seal

- 40<sup>th</sup> Street North older portion.
- 1<sup>St</sup> Street North Due for a crack seal.

## **Blow Patching**

• 30<sup>th</sup> Street North & Riviera Road. Intersection and parts of 30<sup>th</sup> are deteriorating. Possible blow patching could be done in this area.

### Road Signs

• The platted areas of Via Riviera, Bon Homie Valley, Countryside Acres & Pleasantdale Addition will be receiving new 25 MPH Speed limit signs.

#### Miscellaneous

- Properties to consider sending letters to: Wayne Rosenow, 2734 Riverside Ave. No., Russ Schindler, 2624 7<sup>th</sup> Ave. No., Duane Blascziek, 1401 County Road 120 (corner of 62<sup>nd</sup> Avenue) and Bruce & Wendy Theisen, 140 County Road 120, regarding either abandoned & unlicensed vehicles and abandoned property.
- River Vista Lane was "cut into" and concrete was laid down and not asphalt with the

construction of the West Bank project. Check with the city of Sartell whether the road will be replaced as it was prior to the construction project when the project is completed.

The Town Board members viewed all street signs in the Town Hall that could be sold. Clerk Plante will contact Randy Thompson to see if he is interested.
