# AN ORDINANCE ADOPTING A FEE SCHEDULE FOR THE TOWN

The Board of Supervisors of the Town of Le Sauk ordains:

SECTION I. Schedule Adopted. The attached fee schedule is hereby adopted.

SECTION II. <u>Not Codified</u>. This ordinance is transitory in nature and shall not be codified. This ordinance and the fee schedule established hereby shall be placed on file and available for public inspection at the Town Hall.

SECTION III. <u>Effect</u>. The fees set out in the attached fee schedule apply notwithstanding any other fees the Town has established which may be inconsistent. Any other fees imposed by the Town which do not appear on the attached fee schedule remain in full force and effect.

SECTION IV. Effective Date. This ordinance is effective upon publication as provided in law.

# Building Permit Fee Schedule 2022

## Building Permit Fee Schedule based on 1994 UBC Fee Schedule

\$25,000.00 to \$50,000.00 \$349.75	for the first \$25,000.00 plus \$ 9.00 for each additional \$1000.00, or fraction thereof to and including \$50,000.00
\$50,000.00 to \$100,000.00\$574.75	for the first \$50,000.00 plus \$ 6.25 for each additional \$1000.00, or fraction thereof to and including \$100,000.00

## Miscellaneous permit fees

#### Plan Review Fee

- 1. Residential 65% of the permit fee
- 2. Commercial 65% of the permit fee

#### **Commercial Plumbing Permit Fee**

Fee shall be based on 1.5% of the value of the project plus a 25% plan review fee.

### **Residential Plumbing Permit Fees**

- 1. The minimum plumbing permit fee shall be not less than (\$ 50.00)
- 2. The first fixture shall be based on the minimum fee. All fixtures there after shall be computed on a base of (\$8.00) per fixture.
- 3. All rough in plumbing fixtures shall be computed on a base of (\$8.00) per fixture.
- 4. Remodeling of <u>waste/vent only</u> shall be based on the valuation of the work-performed times (1.5 %) of the work valuation.

For the purpose of a plumbing permit, a plumbing fixture shall be taken to mean and include any sink, laundry tub, bathtub, washbasin, drinking fountain, floor drain, or any other plumbing device arranged to be connected with the sewer or plumbing system, either directly or indirectly, and required to be trapped.

#### Commercial Heating, Ventilation and Air Conditioning

Fee shall be based on 1.5% of the value of the project plus a 25% plan review fee.

#### Residential Heating, Ventilation and Air Conditioning

- 1. The minimum HVAC fee shall be not less than (\$50.00)
- 2. For any permit for the installation, alteration or repair of Heating, Ventilation and Air conditioning, the fee shall be one and one-half percent (1.5%) of the valuation of the work or as calculated under the adopted mechanical code.
- 3. Valuation is determined at \$4.00 per square foot floor area.

#### Other Inspections and fees

- 1. The State surcharge computation is based on the permit fee. Surcharge equals .0005 of each permit fee, or (\$0.50) whichever is greater.
- 2. Inspections outside of normal business hours, (\$65.00) per inspection.
- 3. Inspection fee for which no fee is specifically indicated shall be a minimum of (\$30.00).
- 4. Penalty fee: (work without a permit) shall be equal to the total permit fee less surcharge.

## **Fixed Permit Fees**

#### Surcharge

State surcharge is \$1.00 on all fixed fee permits

#### **Fences**

Under 7' no charge

Over 7'- (\$55.00) plus state surcharge

## Gas fireplace and solid fuel burning appliance

(\$ 50.00) plus state surcharge

## Roofing, Siding, Windows

Residential (\$75.00) plus state surcharge.

<u>Commercial/Industrial</u> shall be based on the valuation of the work. The permit shall be based on the building permit fee Schedule Plus the state surcharge.

### Moving structures in or out

Moving a structure in (\$150.00) Plus state surcharge. (Note: in addition, a building permit is required for the foundation and remodel of the structure).

#### Valuation for Permit Fee

Screen porch (\$20.00 per square foot)

Three season porches (\$40.00 per square foot)

Decks (\$10.00) per square foot)

Garages, Outbuildings and Basement finish (\$15.00 per square foot)

## **Permit Refund Policy**

No refund of permit fees after construction begins.

50% of permit fees for fixed fee permits will be retained as a processing fee.

No refund of plan review fees after plans have been reviewed.

State surcharges will not be refunded

## Permit renewal Policy

Expired permits can be renewed at a fee, determined from the value of the work needed to complete the permit, using the current fee schedule, plus 65% plan review fee.
